#### **Registration and Agreement**

To become a BCCA Corporate Sponsor please contact us at [info@bccamping.org](mailto:info@bccamping.org). Upon registration the Sponsor will choose their Sponsorship level and payment will be processed. The Sponsorship fee payable by the Sponsor to the BC Camps Association shall be in accordance with rates published in the Corporate Sponsorship Package of that year or as otherwise agreed to in writing by both parties.

#### **Sponsorship Term**

Sponsorship term is for one calendar year (January 01 to December 31). Registration for the next upcoming Trade Show is included (may fall outside of sponsorship year). Sponsorship and sponsorship benefits will renew automatically upon completion of the year unless the Sponsor terminates sponsorship.

#### **Sponsor Obligations**

The Sponsor warrants that any description relating to its products or services in advertisements or conference distributions are true, accurate, and in no way illegal or defamatory. The Sponsor will supply copy for advertisements, newsletters, and conference distributions prior to copy deadlines, as advertised by the BCCA.

#### **BCCA Obligations**

The BCCA shall use its best endeavours to ensure the appearance of Sponsor's Advertisement but does not accept liability for the non-appearance of any advertisement. The BCCA shall use its best endeavours to procure high attendance to Sponsor's commercial presentations but shall not be liable for actual attendance levels being lower than those anticipated. Unless the parties have agreed to the position of the advertisement in the publication or on the website (in which case this shall be agreed in writing by the parties) the BCCA does not guarantee the position of any Advertisement in the Publication or on the Website.

#### **Exclusivity**

The BCCA does not guarantee that any sponsor will be the exclusive sponsor in a certain sponsorship level or a certain corporate or product category.

#### **Changes / Cancellations**

Any changes made to the sponsorship agreement must be made in writing. In the event of the trade show being cancelled by the BCCA, the trade show portion of sponsorship (\$200) shall be refunded. Refund requests resulting from sponsor cancellations will not be considered if the BCCA deems that the Sponsorship or Conference entitlements have already been provided prior to the submission of the cancellation request.
